2023 OFWC CONVENTION

Can I Vote? Am I a Delegate Or Delegate-at-Large?

Clubwomen attending the State Convention are participating in the yearly business meeting of the GFWC/Ohio Federation of Women's Clubs. Each club has at least one vote on the issues that are presented before the assembly. Know if you are a delegate or a delegate-at-large and may vote.

DELEGATES

- 1. Each per capita club of 25 members or less is entitled to ONE delegate (or her alternate).
- 2. Each per capita club of 26-50 members is entitled to TWO delegates (or their alternates).
- 3. Each per capita club of 51-75 members is entitled to THREE delegates (or their alternates).
- 4. Clubs with more than 75 members are entitled to ONE delegate for each additional 50 members up to a membership of 1,200.
- 5. Direct members may meet at each Convention and elect ONE delegate who is also a Direct Member to represent them.
- 6. Each City-County Federation of 10 clubs or less is entitled to TWO delegates and ONE additional delegate for every 20 additional member clubs.

DELEGATE -AT -LARGE

- 1. OFWC Board of Directors and Junior Board.
- 2. Those members having served in ELECTIVE offices at state or district level.
- 3. Officers and chairmen of GFWC residing in Ohio.
- 4. ALL CURRENT State and District Community Service Program chairmen.
- 5. ALL members of Standing and Special Committees.
- 6. Trustees of all funds and The Buckeye staff.

NOTE: It is possible that members are in both categories, but only one vote per member is allowed. Have clubs decide before registering who will be the club delegate and vote the club's wishes.

*If you are not a delegate or delegate-at-large, you will check the "Non-Voting Member" line on the registration form.

Katie joined Junior Woman's Club of Columbia in 2009, and has served as Fundraising-VP, Membership-VP, Activities-VP and Advisor. Katie served as President from 2013–2014 and used Gandhi's quote as a reminder to her club that they can change the world.

Active in her State Federation, Katie has served as Advocates for Children Chair, Progress Foundation Committee Member, Midlands District President, and President Special Program Chair. Katie was installed as South Carolina Director of Junior Clubs in 2014 and served two consecutive terms. Katie received the Millie Crom Gold Award for Excellence in 2016, 2017, and was named Outstanding Director of Junior Clubs (Category 4) in 2014. Prior to becoming Director-elect of Junior Clubs, Katie served on the GFWC Leadership Committee.

A lifetime supporter of Palmetto Place Children and Youth Services, Katie joined the board in 2010 and is the immediate past Board President. As a member of the capital campaign strategic planning committee, Katie helped plan and execute a successful million-dollar campaign to renovate the shelter. Founded by JWC-Columbia, Palmetto Place is the benefactor of the club's fundraising.

A Carolina girl, born and raised; she attended The University of South Carolina, studying Public Relations and Art History. Katie is a leader in the Growth Operations department at Colonial Life and attributes her GFWC experiences to many of her career successes.

Katie knows that without her family, nothing would be possible. She resides in Columbia with her husband, Matt and son, Collin. Their endless support and encouragement allow Katie to follow her passion.

Special Guest Speaker Kim Buchwalter



Kim Buchwalter came to Springfield Ohio in her high school years, living previously in Kansas, Nebraska, and Colorado. She is a self-employed freight broker, starting her business in 2005. Kim is an active member of The Woman's Town Club serving on several committees; member and treasurer of the Springfield City Federation of Women's Clubs and serves on The Buchwalter House Foundation board. She has been married to her best friend Edward L Buchwalter IV (Eddie) since 2011 and they reside on their farm east of town with their devoted German Shephard Sadie. In her spare time, Kim enjoys reading, working in her flowerbeds and garden, and researching local and family history.

Special Guest Speaker Karen Lutz



Karen Lutz is the owner of Elite K-9 Training & Doggy Daycare in Cortland, Ohio, which she founded in 2006. Karen has always had a passion for all animals, but especially dogs. She believes there are some abilities that just can't be taught. They are God given talents (or gifts). Karen began her journey by showing dogs in the show ring. Her knowledge comes from the numerous professional seminars, working with other trainers and dog handlers, and from learning hands-on, and being in the field. She is a Certified AKC Canine Good Citizen Evaluator. At Elite K-9, she teaches Basic Obedience Levels 1 & 2, Advanced Obedience, and Therapy Dog classes where dogs

and their owners earn their Canine Good Citizen Certificate from the AKC. In addition to running her own training facility in Cortland, she has also taught basic obedience classes at the local Animal Welfare League. Karen is also the Founder and Canine Training Officer of the Mecca, OH K9 Search & Rescue team, which is part of the Volunteer Fire Department. Karen is recognized by veterinarians in her community that have known her and the work she has done. She enjoys training and working with many different breeds of dogs, as well as educating people how to effectively communicate with their dog.

She co-founded Shelter Puppies in 2010, which was the first puppy shelter in Trumbull County to offer puppies who were already vaccinated, spay/neutered, and microchipped, obedience and crate trained before being adopted. Over 1,000 puppies were fostered through Shelter Puppies and found their forever home.

In 2019, Karen's Basic Obedience class was approved for a local prison program, where inmates learn proper training, housing, and handling techniques while caring for and training dogs that have been rescued from several area shelters. Dogs are pre-evaluated for temperament, ensuring each dog finished in the program will be suitable for adoption into a new home. Due to this news, Shelter Puppies shifted its' mission and became Newlife K9's – Ohio, which trains service and emotional support dogs for veterans. The training program lasts one to one and a half years. Once fully trained the dogs are then donated to Working Dogs for Vets, a national organization, who then matches the dog with a veteran. We train the dogs to assist Veterans with Post Traumatic Stress Syndrome, Traumatic brain injuries, mobility issues, and loss of limbs. So far, 24 puppies and dogs have been donated to Working Dogs for Vets or to local veterans.

Karen is married to her husband Bill and has 3 kids. In her free time, she enjoys watching her sons play semiprofessional soccer and race in the GNCC, America's premier off-road racing series.

It seems like everywhere you go today that prices of everything are increasing- from groceries to gasoline to office supplies. COMMUNICATIONS AND PUBLIC RELATIONS

GFWC OH Communications & Public Relations Chairman As GFWC Ohio members, we all know the importance of communicating and interacting with people and organizations in our communities. On an almost daily basis, we have opportunities to talk about our clubs and about projects we are working on or have completed. It's always fun to talk about what we've done, but in order to reach a larger audience, clubs have to communicate their message via the print media and social media.

Having an article with an accompanying photograph in your local newspaper, about a project that has benefited someone in your community is one of the best Public Relations tools ever. People reading about your clubs' generosity and actually seeing you being volunteers in action, is the message we want to convey. Most newspapers have a "Community Page" that runs at least once a week. Find out how to submit your clubs' information and always try to include a good photograph. When an article about your club is in the newspaper, don't forget to send it to your State Communications and Public Relations Chairman, so that it can be posted on our OFWC Facebook page for all the other clubs to see.

And speaking about Facebook, does your club have an active Facebook page? How about Instagram? Social media in the #1 fastest way to communicate with the public and recruit potential new members. You can post about upcoming meetings, photos of projects you are working on, and general information about your club. Always include a few interesting photos that show your clubwomen actively involved in a project or activity. Another good idea would be to post an invitation with all the pertinent information (date, time, location, etc.) of your next meeting. Do this at least a few days in advance of your next meeting.

How well are you communicating with your own members? Does everyone know the time, date, and location of your next meeting? Does someone in your club call or email a member that didn't make it to the last meeting to see how they are? Reaching out to your own members lets them know you care and are looking forward to their involvement in future projects.

If you want to retain your members and grow your club you have to communicate and recognize the efforts of your clubwomen. One good way of doing this is by sending out a birthday message via social media to your club member. Acknowledge their years in the club, offices they may have held, and committees they were involved in. And if possible, include a good photograph of the "birthday girl".

Most importantly, have fun! Smile and show the public what Federation Friendship looks like.

Stafford: Woman's Town Club marks 100 years in Springfield house

A century later, the group is smaller, but members "have a lot of fun and support each other."

The British author and feminist Virginia Woolf's "A Room of One's Own" wouldn't be published for seven more years. But on Jan. 31, 1923, Springfield women held the first official event in "a house their own," the Woman's Town Club at 805 E. High St.

It's clear from the next day's Springfield Daily News that the Springfield Federation of Women's Clubs had found their voice.

The paper reported on Feb. 1 that the Federation would "stand by the Springfield Business and Professional Women's Club in its efforts to close the retail stores of Springfield at 6 p.m. Saturdays" so women could go home.

In addition, Club President Anna B. Johnson "urged cooperation in making Springfield a smokeless city," aligning the club with an effort to protect the poor who were subject to the smoke, dirt and other health hazards associated with living in or adjacent to the Springfield's heavy industries.

The Daily News story also listed club accomplishments of the previous year, including: taking the first city and county survey of the "physically handicapped;" "raising (money for) pensions for the blind;" increasing the budget of the public library; and establishing in its own organization new departments on art, public health and the support of newly naturalized citizens.

All this had taken place just two years after women had gained the right to vote and were beginning to feel more at home in the public sphere.

The move into 805 E. High St. also served as a reminder of the huge role Springfield women had played in that advance during the previous three decades.

The club house is the one-time home of Clementine Berry Buchwalter, who brought women from around the state to Springfield in 1894 to found the Federation of Woman's Club and was a founder of the international General Federation of Women's Clubs. Her extraordinary life is remembered in a bronze statue that sits in the side yard of the Woman's Town Club.

"She was a national figure," said Chris Zechman, current president of the Springfield Federation Women's Clubs.



Member Kim Buchwalter, the wife of Edward Buchwalter IV, the grand-grandnephew of Clementine's husband, Capt. Edward Buchwalter, said that at a time when the ability to read and write wasn't commonplace, "she was instrumental in bringing traveling libraries to Ohio" and the nation.

Kim and Edward restored a Buchwalter presence to the Town Club last year by donating family china and furniture, including the captain's desk, which is displayed in a room with his portrait.

Its presence seems appropriate for a man who was as supportive of the club after his extraordinary wife's passing as he had been of her role in the club movement.

Kim Buchwalter said the Captain often accompanied Clementine on her visits to state-level organizations around the country.

In 1922, the Captain donated \$5,000 toward the sale of his residence to the Town Club, which thanked him warmly.

"The club deeply feels grateful to Capt. and Mrs. Buchwalter (he remarried) in their thoughtfulness at leaving the house in such excellent condition. The walls were re-tinted, some of the woodwork repainted, and all the hard wood floors refinished by the kindness of the late tenants."

Zechman said the remaining \$20,000 of debt "was paid off in the first year," largely by club members' purchase of stock certificates, an indication that many were well off.

That the Town Club added a Tea Room to the structure in 1923 also indicates strong financial support.

Although the support from founding members is remembered when the club provides honorary stock certificates to members today, today's members have been frustrated in their attempts to find out more about the founders.

"We don't really know who they were because they always went by Mrs. John Smith, Mrs. William Lawson," said Zechman. "We don't know their first names."

Kim Buchwalter, who has done her level best to track them down, said the situation was exacerbated when later club members "held on to the tradition" of using their husbands' names in club records as a way of honoring the founders.

Her research has, however, turned up charming and valuable material that can be found on the Woman's Town Club Facebook page. Stories of card parties that drew 250 to the house during the early fundraising efforts are reminders of an organization that once had 500 members.

Such accounts help to explain both the influence of the clubs and the women's hopes at one time to raise \$80,000 to build a performing venue on land behind the current clubhouse.

Zechman says the current membership of 66 is a fraction of what it once was, but the club women remain "true to the spirit" of the Woman's Town Club by supporting community organizations and causes. Among them are Springfield's Civic Theater, Symphony Orchestra, literacy center and the Second Harvest Food Bank of Clark, Champaign and Logan Counties.

In addition to all that, she said, they uphold another women's club tradition: "We have a lot of fun and support each other."

One last thing: The club rents space for parties and occasions of all kinds for those who don't have ample rooms of their own.

History of Women's History Month

The actual celebration of Women's History Month grew out of a weeklong celebration of women's contributions to culture, history and society organized by the school district of Sonoma, California, in 1978. Presentations were given at dozens of schools, hundreds of students participated in a "Real Woman" essay contest and a parade was held in downtown Santa Rosa.

A few years later, the idea caught on within communities, school districts and organizations across the country. In 1980, President Jimmy Carter issued the first presidential proclamation declaring the week of March 8 as National Women's History Week. The U.S. Congress followed suit the next year, passing a resolution establishing a national celebration. Six years later, the National Women's History Project successfully petitioned Congress to expand the event to the entire month of March.

<u>The GFWC Belpre Woman's Club</u> observed Women's History Month by five members choosing a woman in history that meant something to them. Rose Logston, GFWC Great Lakes Region Vice President choose her ancestor, Bathsheba Rouse Green. They are direct descendants of Myles Standish who came over on the Mayflower.
